CON SHEAHAN EGF&NC JUNIOR INCENTIVE SCHEME

- 1. A player must have played junior football or netball at the East Geelong Football and Netball Club to be eligible to access the Con Sheahan EGF&NC Junior Incentive Scheme (Incentive Scheme). U18 Football and U19 Netball are classified as juniors.
- 2. From 2022, all junior footballers playing in U14s or a younger grade, and junior netballers playing in U15s or a younger grade, are eligible for payment from the Incentive Scheme when they play:
 - 50 senior football games or A Grade netball games; or
 - A total of 100 senior and reserves football games or A, B, C and D Grade netball games.
- 3. From 2022, all junior footballers playing in U16s or U18s, junior netballers playing in U17s or U19s, or footballers/netballers that have graduated to senior football/netball but have not yet become eligible for a payment from the Incentive Scheme, will become eligible for payment from they play:
 - 25 senior football games or A Grade netball games; or
 - A total of 50 senior and reserves football games or A, B, C and D Grade netball games.
- 4. If a football or netballer plays in more than one game on any weekend, for the purposes of the Incentive Scheme the footballer or netballer is only credited with one club game.
- 5. Only netball games played for premiership points as part of the Geelong & District Football and League competition count towards total netball games played.
- 6. A junior/senior player becomes ineligible for payment from the Incentive Scheme if they leave the club to play football or netball at another club, irrespective of whether they return to the club at a later date and then play the required number of games outlined in point 2.
- 7. Rule 6 above does not apply where:
 - the player moves to a club designated as a Premier Competition in AFL Victoria's Player Points System Policy for the purposes of advancing their football and netball.
 - the East Geelong Football and Netball Club is unable to field a team in a junior age group in a certain year and a player is required to transfer to another club to continue to play football/netball, and the player returns in the following season.

In both instances above the player will remain eligible for payment from the Incentive Scheme should they return to the club at a later date;

- 8. The payment a player is eligible for is calculated using the following formula:
 - \$250 multiplied by the number of junior football or netball grades (not years) that the player played in (up to a maximum of \$1,000).

For example, if a footballer represents the East Geelong Football and Netball Club at U9, U11, U14, U16 and U18 levels (5 levels) he would be eligible for a payment of \$1,000.

If a netballer represents the East Geelong Football and Netball Club at U13, U15, U17 and U19 levels (4 levels) she would be eligible for a payment of \$1,000.

- 9. The actual payment of an incentive to an eligible player can only occur once that player has finished representing the East Geelong Football and Netball Club at junior level (that is the eligible player becomes too old to represent the club at either U18 football or U17 netball level).
- 10. Payments from the Incentive Scheme will be made to each eligible junior at the East Geelong Football and Netball Club's annual Presentation Night.
